Attorney Youssef KNANI served as the president of the Arbitral Tribunal.
- CIRDI Arbitration: Tunisian State vs. a major player in banking sector. The firm acted as the legal advisor of The Tunisian State.
- International Arbitration: This litigation involved a Tunisian company operating in public works vs. a Spanish company. The litigation concerned compensation for damage resulting from wrongful termination of negotiations relating to the olympic stadium construction. Banking Law / M & A / Business Law
